

CL Tennis, Inc. Waiver of Liability

The undersigned parent, legal guardian or natural guardian of _____ (herein called "Child")

The undersigned has enrolled such Child in the Summer Camps @ Chandlers Landing offered by CL Tennis, Inc., which is located at 501 Yacht Club Drive, Rockwall, TX 75032 (the "Facilities") and the undersigned does hereby agree and confirm in their own behalf and in behalf of the Child as follows:

1. I fully recognize the risks of injury or illness inherent in participation in any fitness or athletic program, and I represent to CL Tennis, Inc. (collectively referred to herein as the "Club") that I have consulted my child's personal physician or other health authority and my Child is physically capable of participating in Summer Camps @ Chandlers Landing.
2. I in behalf of myself and my Child, do hereby voluntarily release, discharge, waive, and relinquish any and all actions or causes of action for any thing whatsoever, including without limitation, for personal injury, property damages, or wrongful death occurring to my Child and arising as a result of engaging in Summer Camps @ Chandlers Landing or in relation to any activities incidental thereto, wherever or however the same may occur and for whatever period said activities or instructions may continue (hereinafter collectively referred to as the "Claims"). I for myself, my heirs, executors, administrators and assigns, and for the Child, do hereby release, waive, discharge and relinquish the said Claims, and any claim, action or cause of action in relation thereto which may hereafter arise for my Child or my Child's benefit, for me and/or for my estate. I further agree that under no circumstances will I, my child or the heirs, executors, administrators and assigns of either of us prosecute or present any claim for anything whatsoever, including any of such Claims against the Club and/or the officers, directors, agents, servants, employees, parent company, subsidiaries, participating contractors, coaches, or volunteers of either of the Club entities (collectively referred to as the "Club and its Agents") and I agree to indemnify and hold the Club and its agents harmless from any and all liability of any kind or nature whatsoever in connection with and Claims, including claims for negligence, personal injury and/or property damage, related to my Child's participation in 2011 Summer Camps at Chandler's Landing, and any program or aspect thereof, whether such Claims shall arise by negligence of any person or entity, or otherwise. **IT IS MY INTENTION BY THIS INSTRUMENT TO EXEMPT, RELEASE AND RELIEVE THE CLUB AND ITS AGENTS, INCLUDING THE, CONTRACTORS, COACHES, AND VOLUNTEERS OF EACH ENTITY FROM LIABILITY FROM PERSONAL INJURY, PROPERTY DAMAGES OR WRONGFUL DEATH CAUSED BY THE NEGLIGENCE OF ANY PERSON OR ENTITY**
3. I further hereby agree to indemnify and hold harmless the Club and its Agents from any and all claims, actions, demands, costs, liabilities, expenses or judgments whatsoever, including attorneys' fees and costs, which might arise from or be in any way related to my Child's participation in Summer Camps @ Chandlers Landing.
4. I hereby voluntarily execute and deliver this Release and Indemnification to the Club and its Agents to induce the Club to permit my child's participation in Summer Camps @ Chandlers Landing, and I hereby acknowledge that such participation is at my and my Child's own risk and without any representations of any kind or character having been made by the Club and/or its Agents and/or its officers, directors, agents, servants, employees, parent company, subsidiaries, contractors, coaches, and volunteers. I acknowledge that I have read the foregoing and have been fully advised that I should contact my child's personal physician or other health authority prior to commencing the Summer Camps @ Chandlers Landing.
